#### **Imam W. Deen Mohammed**

*"That's a good suggestion and I'm aware of the problem and the problem has been going on for years and it's not all intentional it's just that some people have a lot of things to do and they miss being able to give priority to matters that demand that priority and I tell them that any Imam in our community who wants any tape that I have done, I'm telling you this so you will know, as long as they will agree to make private use of it any of you can have it all you have to do is just write us without any cost, you don't have to pay anything for it.*

*We'll give you one copy for your personal use without you paying a penny for it. The office will send the tape to you it doesn't cost that much. Now if I make a speech in your area, if you want a copy of the speech in your area as your guest you invited me there, if you're an Imam that I know is innocent, you know yourselves, you know all of you are not innocent, I will also agree, sign an agreement that you can sell that tape in your city, maybe I'll say in your state and all revenue from that selling of that tape except for cost will stay with you to build up your efforts there. And I don't want to name anybody but certain ones have that, they have gotten it and they know they can get it, so I want all of you to know that is another offer that my office makes to the Imams that whenever I give the lecture as your guest you can make use of that tape because all of us need money we can't exist without it, you have to have your bills paid you have to have so many things, the Imams need money.*

*It's hard to find an Imam who is able to take care of or he has people in his group that is able to take care of the financial need. Always the financial burden is too much on us, we can't even meet it so that's a way of helping you. And you can discuss other publications that will help you in that area just let my son Wallace D. Muhammad the II know, contact him and let him know and if any of you don't have the number you can write it now it's in the paper but I'll give it to you the publication phone number is (708) 862-7733 and ask for Wallace Muhammad he's the manager and not only that he's also the boss, he is owner, we own it together if I should die right now and not get home it's his, I'm trying to tell you something."*

The Mosque Cares sponsors those events and there are the exclusive rights of the Mosque Cares upon my authority. I don't know if you know this but any speaker, if he speaks no one can have his words in print or any other form legally without his permission. That includes the TV networks. When I go on television I have to sign an agreement with them for them to use what I do on their own show. It is their show but it is my property. What comes out of my mouth is my property. I give it to The Mosque Cares and I give it to my son. "*
